



## WFGE "GRAB A GRIZZLY" CONTEST RULES 2010

WFGE-FM Radio, a Forever of PA Inc. radio station, in conjunction with Unlimited Cycle Center in Tyrone, Pennsylvania is conducting a contest entitled "Grab a Grizzly".

- 1) The contest will commence on Saturday, April 10th, 2010 and conclude on Saturday, June 19th, 2010. The contest will run seven days per week during this time period.
- 2) The grand prize is a 2010 Yamaha Grizzly 4x4 350 ATV provided by participating dealer Unlimited Cycle Center. This is not a lease!
- 3) Listeners will listen to Froggy 101 for the cue to call. The "X" caller at 1-888-818-3764 becomes a qualifier to win the ATV. Listeners can only qualify one time during this promotion.
